


■ MANUFACTURE

This Reference Product comes from sites that have received ISO14001 certification.



■ DISTRIBUTION

Products are distributed from logistics centres located with a view to optimize transport efficiency. The Reference Product is therefore transported over an average distance of 780 km, by road from our warehouse to the local point of distribution into the market in Europe.

Packaging is compliant with European directive 2004/12/EC concerning packaging and packaging waste. At their end of life the recyclability rate is 100 % (in % of packaging weight).

END OF LIFE

Product end of life management is integrated into product design by the development teams. The disassembly and sorting of components or materials is made as easy as possible with a view to recycling or another form of reuse.

• **Recyclability rate:**

Calculated using the method described in technical report IEC/TR 62635, the recyclability rate of the product is estimated at 82 %. This value is based on data collected from a technological channel operating on an industrial basis. It does not prejudge the effective use of the channel for electrical and electronic products at the end of their life.

Separated into:

- plastic materials (excluding packaging) : 60 %
- metal materials (excluding packaging) : 10 %
- other materials (excluding packaging) : 0 %
- packaging (all types of materials) : 12 %



ENVIRONMENTAL IMPACTS

The evaluation of environmental impacts examines the stages of the Reference Product life cycle: manufacturing, distribution, installation, use and end-of-life. It is representative of products marketed and used in Europe in compliance with associated product standards.

Distribution	Transport between the last Group distribution centre and an average delivery to the sales area.

End of life	In view of the data available on the date of creation of the document, and in accordance with the requirements of the PCR of the «PEP ecopassport» programme, transport of the Reference Product by road only once, over a distance of 1000 km, to a processing site at end of life was counted.
